# 6 Deputy Registrar's Report

Michael Price, Deputy Registrar reported on the following items:

- Year end statistics for 2015. PEO received 5014 new applications. This represents the second highest level of applications received in one year. Council instituted the financial credit program in 2007 to CEAB grads and new immigrants within six months of landing. Almost half of the applications that came through last year came through the financial assistance program, 48%.
- There were 2449 individuals that were licenced in 2015. The second highest amount of people to be licenced in PEO history.
- Admission officials held a meeting in Ottawa to discuss the admission reference point project.

- PEO launched its new database called, Aptify on April 1, 2016.
- Ontario Fairness Commission. There was a meeting to discuss the 2017 assessment process. The 2017 assessment will be a full assessment for all regulators.
- The PEO AGM is in two weeks. There will be a webcast for those who cannot attend in person.

# 8.1 Licensing Committee Update

Barna Szabados reported that the LIC has been going through the recommendation of the LPTF concerning academics. The LPTF has suggested that the PPE can be written at any time. There is no restriction in the regulation or the current act as to when an applicant can initially write the PPE. The ARC discussed at length issues around the PPE and the length of time an applicant has before their file should be closed.

It was requested that the previous motion that was moved by Waguith ElMaraghy and seconded by Al Stewart at the March 18, 2016 ARC meeting be withdrawn. (*The PPE as a principle should be taken as soon as possible after meeting the academic requirements*).

A New Motion was introduced by Waguih ElMaraghy and seconded by Al Stewart. **Motion**: Amend regulation 37 to read, an applicant for licence must attempt PPE no later than two years following the date of submission of the application for membership by the applicant to the registrar.

# DEFEATED

A working group from the ERC, ARC, EDTF and LIC met for the first time on March 18, 2016 to discuss this new strategy. A list of potential applicants from one company was circulated. Out of the 23 names that were presented, there are 4 who potentially qualify to apply for a P.Eng. There are 7 who possibly could apply for a Limited Licence. The challenge will be those who do not have the academics or experience for a limited licence. The next meeting for the working group is May 13, 2016.
