#### 4. <u>Matter(s) Arising from the Minutes</u>

There were no matters arising from the minutes.

#### 5. Chair's Report

The Chair reported that:

- On April 24, 2015, he attended the Volunteer Leadership Conference along with ARC Vice-Chair, Leila Notash. Chairs and vice-chairs from all chapters and committees were represented. The main issue discussed was communication and the incorrect information PEO registrants and applicants have regarding the application process. The Chair requested that, if asked by chapters, ARC members go and brief them on the application process. The Chair requested that Shamim Sheikh provide an update on an event he recently attended with Manager – Admissions, Moody Farag.
- Shamim Sheikh reported that the University of Engineering and Technology Lahore Alumni Association hosted an event on April 25, 2015 where the licensing requirements were clearly enunciated. With more than forty people in attendance, new applicants and older applicants were given the accurate details on the licensing process.
- He attended the PEO AGM on April 24 and 25, 2015.
- He was invited to attend an Engineers Canada workshop on May 6, 2015. The discussion will revolve around accreditation. In relation, a letter from the CEAB to Paul Amyotte, President of Engineers Canada, was distributed to the committee. An update of the workshop will be sent to the committee prior to the next ARC meeting.

# 6. Deputy Registrars Report

The Deputy Registrar reported that:

- The Briefing Note submitted by Roydon Fraser, titled: *Fundamental Academic Admissions Principles* was approved by council at the April 25, 2015 Council meeting.
- The Ontario Fairness Commission is undergoing a mandate review.

• Engineers Canada's Education Credential Assessment proposal RFP was issued by the Federal Government.

New requirements included:

- 7 out of 12 Associations will need to be in agreement with the proposal instead of 2 previously required.
- Assessments are now for academic requirements for licensure rather than level of education.
- APEGBC has stated that they will not support Engineers Canada's proposal without further information.
- APEGNB has stated that they will require all associations to support Engineers Canada's proposal before they will support it.
- A Council meeting was held after the AGM on April 25<sup>th</sup>, 2015. He reported that there was now increased ARC and ERC recognition at Council meetings. Changiz Sadr, a member of the ERC, was now on the PEO Executive Committee and Bob Dony was appointed as PEO Vice-President

# 8. Procedural and Related Matter(s)

# 8.1 <u>LEL Implementation ARC Subcommittee Update</u>

Lawrence Fogwill, Manager – Registration, reported on the progress of the joint ARC/ERC Limited Licence Working Group on the new Limited Licence provisions. A flow chart titled, Limited Licence Application Process, was distributed to the members of the committee along with a checklist outlining the steps that need to be taken at each stage of the process.

Chair, Barna Szabados, outlined ARC's role in the process and then suggested that a dry run of the process be conducted. He requested that an example of a civil, electrical and mechanical application be provided. Moody Farag, Manager – Admissions, recommended a half day workshop with the ARC and ERC volunteers, and once the process was clear, that information would be shared with the committee.

The matter was discussed at length by the committee.

# 8.2 Licensing Committee Update

Barna Szabados reported that a Licensing Committee meeting was held on April 30, 2015. No motions were passed because quorum was not met for parts of the meeting.

# 8.3 Legislation Committee Update

Bob Dony reported that the regulations for the Limited License received Cabinet approval. In the new regulations "forms" are part of the regulation, therefore they needed to be approved by council. The forms were approved at the April 25, 2015 Council meeting.

He also reported that the majority of last year's Legislation Committee were re-elected. Because it is a board committee of council, the committee is re-formed each year. The position of Chair is up for nomination.

# 8.4 Red Book Subcommittee

Chair, Barna Szabados, thanked Seimer Tsang for the editing work being done on the Red Book.

He reported that since the last Red Book update there were some major policy changes, and those were added to the Red Book. They now require ARC approval.

The changes included:

- GMI (General Motors) Graduates
  - Will be left in the Red Book for historical reason but any future applicant would be treated the same as regular applicants.
- Mobility Agreement
  - New wording will be taken from an Engineers Canada document. The document will also be included in the Red Book.
- PAP (Preparedness Assessment Program)
  - The PAP section will be removed from the Red Book.
- Clock Start for Experience
  - Currently in the Red Book in red print because it has not been approved yet. The ERC Subcommittee is meeting on May 19, 2015 and will discuss the item. Once it is approved by the ERC Committee, and any changes are added, it will be put into the Red Book.

Chapters one through eight of the Red Book are almost complete. Chapters nine through eleven are still to be updated.

# 8.5 <u>EChat Forum Items</u>

# 8.5.1 *Distance Education*

Seimer Tsang provided a handout for the committee titled: *Distance Education Assessment Guidelines (for the Red Book).* It outlined a concern with ABET-accredited online engineering programs. The matter was discussed at length by the committee. It was suggested that the committee wait until an ABET-accredited distance education application is submitted and then the committee can revisit the issue.

# 8.6 CEAB Update

Bob Dony reported that during a recent conference call, the CEAB expressed their displeasure with some Dean's saying there is too much work required for accreditation. CEAB responded to this in a letter to Engineers Canada's President, Paul Amyotte, dated April 28, 2015. A copy of the letter was distributed to the committee.

He noted that the main concern is the lowering of accreditation criteria to the degree that the regulators would no longer be confident with an applicant's academic formation.
