8.6 Redbook policy number 8.3.6 "applicants with International Degrees Who Possess Postgraduate Academic Qualifications

Barna Szabados reported on a reoccurring issue with civil engineering applicants. Civil applicants who are missing transportation courses in their programs are being assigned gap exams. If an applicant does not have transportation courses it is not a gap when the applicant will never work in transportation. McMaster University and University of Victoria are CEAB accredited programs that do no have any transportation in their curriculum.

Motion: It was moved by Stelian George-Cosh that each subcommittee review sections A and B of PEO boardsheets, the first paragraph of article 8 in the red book

and come up with a recommendation of what the requirements should be for their discipline and how their boardsheet can be revised. Seconded by Waguith ElMaraghy.

It was suggested to have a pool of courses to choose from, in addition to the current grouping of A and B. The process can be made more flexible by defining core subjects for each program and creating a list that will constitute the required subjects?

Civil Engineering applicants who have Master's degrees from international institutions are being assigned confirmatory programs even if they have taken several post graduate courses. The committee discussed the issues at length. The seven files were referred back to the Civil group; they will make a decision at the next meeting.

8.7 Mechatronics Syllabus

Stelian George-Cosh reported on the subcommittee that was formed to compare mechatronic programs at Canadian Universities. Most Mechatronic programs cover the basic and complimentary studies. There are many different flavours of mechatronics programs which concludes that there needs to be some flexibility as there are discrepancies with each program. The subcommittee will come up with recommendations for the next meeting.

8.9 ERC Report

David Kiguel reported on the following items:

- ERC met on October 26, 2016.

Judith Dimitriu discussed a file from McMaster University B. Tech Automotive program. She noted that there is an inconsistency in the number of exams applicants are assigned. There should be the same number of exams for everyone in the program. It was suggested that this program needs a prescribed examination program. It was clarified by staff that the McMaster B. Tech subcommittee is waiting to receive information from the University before making a recommendation on a prescribed examination.
