Call to Order

6. <u>Activity Reports</u>

- 6.1 Santosh Gupta reports that in the September 2015 Council Meeting, two motions were passed which may be of interest to the CEDC. First, PEO resumes sending the printed edition of the Engineering Dimensions magazine to all PEO licence holders and EITs, unless the member requests for the digital edition. Second, Council affirms its intent to ask the membership to ratify in a referendum any mandatory requirement to participate in a continuing professional development competency and quality program.

- 6.3 Michael Price reported that if there is an available Engineers Canada Report to PEO Council, it will be passed along to the CEDC.

7. <u>New Business</u>

7.1 Chair Eric Nejat announced that he has accepted Gerry Webb's resignation from the CEDC. Denis Dixon presented the certificate of appreciation for Gerry's 34 years of service to the committee.

The Chair also thanked Roy Fletcher for his many years of service on the CEDC, as this was his last meeting.

7.2 Denis Dixon reported that a subcommittee of the Professional Standards Committee (PSC) is working on a guideline for building inspection. Once a guideline is in place, the CEDC can mark the applicants who do remedial building work or condition surveys and give them the endorsement for building inspection work. Having the CEDC involved in this process helps us control how competent these inspectors would be.

7.3 The Eastern Subcommittee wants to be able to identify via the CofA Directory which engineering companies have the Permission To Use (PTU), or have the words "Consulting Engineering" in their name. This would be helpful in promoting the value of the designation. Staff Advisor Lawrence Fogwill was requested to send a note to Registrar for the CofA Directory to have a filter which will show the PTU holders.
