## 3. Partner reports

#### **Engineers Canada**

The Engineers Canada representative was absent. No items reported.

## **OSPE (Matthew Jelavic)**

- Sandro Perruzza had a meeting with Construction Design Alliance of Ontario (CDAO).
- Some of the highlights of this meeting included:

- o OSPE/RCCAO/GTASWCA Excess Soils Report
- Update from the Canadian Construction Association Meeting in Halifax which demonstrated that Ontario is ahead of the other provinces on topics including
- o standardized contract language and prompt payment legislation.
- Discussion on Exclusion Clauses and other contract requirements that are beginning to be imposed by Municipalities
- Federal/Provincial Infrastructure Initiative, including a proposed meeting with Federal Infrastructure Minister Sohi
- On July 25<sup>th</sup> OSPE hosted a members meeting at the Rogers Cup
- OSPE has received a reply from the Hon. Glen Murray, Minister of Environment and Climate Change, regarding OSPE's view that the Ontario Government is underutilizing their expertise of Ontario's Engineering Community. In the letter, the Minister acknowledges OSPE's numerous and valuable submissions on Energy and within his own Ministry, and gives a commitment to stay engaged with OSPE
- OSPE continues with ongoing work with the Ontario Chamber of Commerce on Sustainable and Economical Infrastructure, with RCCAO and GTAWSCA on Excess Soils, with OACETT on an upcoming E3, and with numerous chapters on engagement events.
