1. Call to Order and Opening Remarks

Warren Turnbull called the meeting to order at approximately 7:30 am.

2. Approval of Agenda and Minutes

Nick Colluci moved a motion to approve the Minutes of the January 16th, 2018 GLC meeting. Gabe Tse seconded the motion. Motion carried.

Action items from the last meeting were reviewed.

3. Report from Manager, GLP Programs

- GLP Info Notes the GLP Info Note on Bill 177 has been completed. The next step is for it to be
 included in the Registrar's Report to PEO Councillors. If there is no feedback or concerns from
 the Councillors after two weeks, then it can be distributed to the GLP chairs and posted on the
 website. There is another GLP Info Note that needs to be prepared on the expected results for the
 Government Liaison Program, as per one of the action items from the GLP Implementation Plan.
- Take Your MPP to Work Days there were no Take Your MPP to Work days held in January.
- Queen's Park Day the rooms have now been booked and confirmed for October 24th, 2018. Jeremy Carkner to let CEO know our date and check when CEO plans to hold their event.

- GLP meeting activity report A verbal summary of the MPP meetings held in January 2018 was provided to the committee. There was not much activity other than attending MPP levees and chapter events. There were a total of 11 MPP meetings held in January, mostly community events or Licencing ceremonies.
- Actions on the Implementation Plan for GLP 2.0 we are continuing to work on the
 implementation plan activities. We are currently working on the GLP chairs newsletter for first
 quarter of 2018. A guidance document for the GLP Weekly has been drafted by Howard. The
 action item to develop a GLP Info Note on expected results for the GLP program is still
 outstanding and still needs to be worked on. Howard Brown volunteered to develop it.

Bruce Matthew is the new Chief Executive Officer of Consulting Engineers of Ontario. Former Chief Executive Officer Barry Steinberg, will assist in the transition. CEO is continuing to track government relations issues as reported in the January GLC meeting.

OSPE: Patrick Sackville was not present.

5. Report from Subcommittees and Working Groups

Audit Implementation plan subcommittee – Warren Turnbull

Warren Turnbull updated the GLC on the status of the response to the OSPE and CEO letters regarding the GLP 2.0 Implementation plan. Council approved the PEO response and the GLP 2.0 Implementation Plan report will be revised accordingly and sent to OSPE and CEO.

Enhanced Government Outreach –Development of draft text for a leave behind card is still to be developed.
