#### 1. Call to Order and Opening Remarks

Warren Turnbull called the meeting to order at approximately 7:00 pm.

#### 2. Approval of Agenda and Minutes

Daniel King moved a motion to approve the Agenda. Tim Kirkby seconded the motion. Motion carried.

Tim Kirkby moved a motion to approve the Minutes of the December 12th, 2017 GLC meeting. Daniel King seconded the motion. Motion carried.

Action items from the last meeting were reviewed.

#### 3. Report from Manager, GLP Programs

- Regional Academies vs Government Relations Conference Jeannette Chau asked the GLC for direction on what GLP training they would like to hold in 2018 – either GLP Regional Academies again or a joint OSPE/PEO Government Relations conference similar to what had been held in 2016. All GLC members present wished to hold a conference, given that PEO has held Regional GLP Academies in 2017 and it would be good to alternate training approaches. Jeremy Carkner abstained from the decision making.
- GLP Info Notes a GLP Info Note on Bill 177 is being worked on by the Regulatory Issues subcommittee. There is another GLP Info Note that needs to be prepared on the expected results for

the Government Liaison Program, as per one of the action items from the GLP Implementation Plan.

- Take Your MPP to Work Days there were no Take Your MPP to Work days held in December
- GLP meeting activity report A presentation summary of the MPP meetings held as of December 31, 2017 was provided to the committee. There were nine MPP meetings held in December, mostly community events or Licencing ceremonies. There was one joint OSPE PAN/PEO GLP constituency office meeting held with MPP Yvan Baker. A copy of the activity report was provided with the Agenda.
- Actions on the Implementation Plan for GLP 2.0 we are continuing to work on the implementation plan activities. The first GLP Chair quarterly newsletter has been developed and was sent out to all the GLP chairs on November 17th. The next one will be sent at the end of February. A Guidance document for the GLP Weekly is being drafted by Howard. There was an item to develop a GLP Info Note on expected results for the GLP program, so this is a new GLP Info Note that still needs to be worked on.

The ESSCO VP Services had resigned and an election was held to obtain a replacement. Tiffany Joseph is the new ESSCO VP Services.

A new ESSCO website is being planned.

ESSCO is planning to launch a new "Friday Features" which will showcase select engineering students every Friday. They are also introducing a friendly board games competition where they will pit Ontario school teams against each other.

**OSPE**: Patrick Sackville provided an update on OSPE activities.

OSPE has brought in public policy interns as part of their policy committees.

OSPE was very favourably featured in a Legislature report, and in particular received praise for their contributions to the energy reports.

OSPE is preparing submissions re: Parking structures, Airborne emissions, Long term Infrastructure plans, and will be presenting to the Finance committee on the 2018 Ontario Budget

OSPE will be launching an advocacy campaign for the upcoming election which will engage all candidates and include public engagement. More details will be available in a couple of weeks.

**Regulatory Issues subcommittee** – the subcommittee met on January 9, 2018 and reviewed updates from the Registrar's report that dealt with any upcoming regulatory items.

Howard Brown provided information on upcoming Levees.

### CEO Update (sent by Jeremy Carkner)

## **CEO Government Relations Activity Summary - PEO GLC**

January, 2018

#### Bill 142 – Construction Act (Act to amend the Construction Lien Act)

- Act was passed and received Royal Assent December 12, 2017
- Substantial provisions of the new law remain to be proclaimed this is expected early in 2018
- Significant regulatory development is required to enable the key provisions of the Act public consultations are expected early in 2018
- CEO was successful in having the vast majority of its members' issues favourably addressed in the legislation
- The Act would be implemented in phases over a period of time prescribed by the Ministry of the Attorney General given its nature and scope

#### Infrastructure Ontario – Nothing new to report

- CEO remains engaged with the agency on issues stemming from its Infrastructure/AFP and Real Estate Divisions including:
- Procurement practices
- Contract language
- Project Pipeline
- Industry market capacity
- CEO has been successful in achieving changes in the Real Estate VOR Agreement, permitting consultants to secure professional liability insurance for these projects
- Work continues to have these changes adopted as the new standard in the IO supplementary conditions for proposed real estate division agreements, beyond the VOR

# Bill 6 – *The Infrastructure for Jobs & Prosperity Act* – Revised Municipal Asset Management Planning Regulation

- The Government of Ontario's new municipal asset management planning regulation (O. Reg. 588/2017 under the Infrastructure for Jobs and Prosperity Act, 2015) came into effective January 1st.
- Given the nature of the proposed new regulatory requirements municipal compliance will be phased-in over 6 years and in full effect July 1, 2024
- CEO will continue to work closely with provincial officials in the implementation of this new regulation and its requirements

#### Ontario Long Term Infrastructure Plan (LTIP) – Nothing new to report

- CEO has played an active role in developing portions of the LTIP with provincial officials
- Government released "Building Better Lives: Ontario's Long-Term Infrastructure Plan 2017" on November 28th
- CEO will be working with officials to develop and implement means for effective execution of the plan, facilitating fulfillment of Ontario's infrastructure initiative over the coming years
