## 1. Call to Order and Opening Remarks

Warren Turnbull called the meeting to order at approximately 7:35 am.

### 2. Approval of Agenda and Minutes

Tim Kirkby moved a motion to approve the Agenda. Gabe Tse seconded the motion. Motion carried. Tim asked about vacant positions on the committee. Warren responded that the positions have been filled and only need to be approved by Council.

Gabe Tse moved a motion to approve the Minutes of the last GLC meeting. Jeremy Carkner seconded the motion. Motion carried.

Action items from the last meeting were reviewed. Jeremy checked with CEO and their Queen's Park Day is 2 days before PEO's. CEO will be holding it on Oct 22nd. Unfortunately, this was the best time for CEO.

Provincial election questions for candidates - Two questions for PEO have been drafted. We will create one joint OSPE/PEO list. OSPE will produce three to four of the questions. PEO will produce two to three of the questions.

## Report from Manager, GLP Programs

- GLP Info Notes the GLP Info Note on Bill 177 was sent to Councillors via the Registrar's report, then to all the GLP chairs and is also posted on the PEO website.
- Take Your MPP to Work Days there were no Take Your MPP to Work days held in January or February. Howard Brown asked Jeremy Carkner if there were companies that CEO knows that might be interested in participating. Jeremy will check.
- GLP meeting activity report A verbal summary of the MPP meetings held in February 2018 was
  provided to the committee. There was not much activity other than attending MPP levees and
  chapter events. There were a total of 23 MPP meetings held in February Year-to-Date, mostly
  community events or Licencing ceremonies. There was one joint OSPE PAN/PEO GLP meeting
  held in February.
- Actions on the Implementation Plan for GLP 2.0 we are continuing to work on the
  implementation plan activities. We are currently working on the GLP chairs newsletter for first
  quarter of 2018. A guidance document for the GLP Weekly has been drafted by Howard. The

## 3. Report from Partners

Engineers Canada: Rakesh Shreewastav provided an update on Engineers Canada activities Hill Day 2018 -due to the federal budgets release date, Engineers Canada had to re-schedule it's Hill Day until April 24, 2018 from 9:00am-5:00pm. As per last year, this event will include an evening reception on Parliament Hill. All Ministers, members of Parliament and Senators and their staff have been invited to attend the reception. Engineers Canada is in the process of finalizing meetings for participants.

<u>Federal Budget</u>-on February 27, 2018, the Honourable Bill Morneau, Canada's finance minister, tabled Budget 2018, *Equality and Growth: A Strong Middle Class*, in the House of Commons. Engineers Canada was invited by the Minister of Finance's office to take part of the stakeholder lockup. Engineers Canada was please with the announcements of; funding in STEM research, diversity and gender equality in STEM, a national climate date collection, and support for indigenous communities as it relates to infrastructure. A <u>press release</u> was issued and made available on Engineers Canada's website, and full budget analysis will follow in the next week.

**ESSCO**: Angel Serah provided an update on ESSCO activities.

**OSPE**: Patrick Sackville provided an update on OSPE activities

OSPE has been working on a new campaign, #EngineeringAlly, that they are planning to launch for the upcoming provincial election. They will be asking election candidates from all parties to sign an #EngineeringAlly pledge that if they are elected they promise to do the five things outlined in the pledge. The GLC discussed the campaign and ways they might provide support, for example, by asking our GLP representatives to help the OSPE PAN reps spread the #EngineeringAlly message and get the #EngineeringAlly pledge signed. **GLP Chair Engagement** – the quarterly call with the GLP chairs was held on Thursday, March 8, 4:00-5:00 pm. Items that were covered were Chapters new riding allocations; Professional Engineers Day on March 1<sup>st</sup>; Take Your MPP to Work Days; upcoming provincial election; Queen's Park Day and Government Relations conference; GLP scorecard; GLP chair questions. The GLP Scorecard needs to be revised for this year. A request was made for volunteers to work with the GLC to help modify the GLP Scorecard.

**Regulatory Issues subcommittee** – the subcommittee met on March 6, 2018 and reviewed updates from the Registrar's report that dealt with any upcoming regulatory items.

The GLP Info note for Bill 177 has been completed, sent to Council, the GLP chairs, and posted on the website.

Most of the discussion revolved around brainstorming ideas for questions to be distributed to provincial election candidates prior to the June 7 provincial election. Two draft questions have been developed.

## Queen's Park Day subcommittee -Committee has not met yet.

Date has been confirmed for October 24. Rooms have been booked at Hart House for the Government Relations conference being held during the day 8:30am -4:00pm) prior to the MPP reception at Queen's Park 5:00-7:00 pm.

## Audit Implementation plan subcommittee – Warren Turnbull

### **Ontario Budget**

Government will present its pre-election budget Wednesday March 28th

CEO's annual Queen's Park Day has been scheduled for Monday October 22, 2018

## **Municipal Class Environmental Assessments**

• Ministry of Environment & Climate Change is holding working group session with infrastructure stakeholders to discuss its efforts to update, improve, streamline its municipal class environmental assessment process

## Bill 142 – Construction Act (Act to amend the Construction Lien Act)

- First round of consultations pertaining to regulations for lien & holdback provisions were completed March 19th
- Government will publish completed regulations once feedback input has been analyzed
- New regulations will be in place and the corresponding portion of the Act will be proclaimed for the July 2018 deadline

## Infrastructure Ontario – Nothing new to report

- CEO remains concerned with the agency's Infrastructure/AFP and Real Estate Divisions procurement policies including: Contract language, Project Pipeline, Industry market capacity
- CEO has been successful in achieving changes in the Real Estate VOR Master Agreement, but its contract supplementary conditions remain uninsurable

# Bill 6 – The Infrastructure for Jobs & Prosperity Act – Revised Municipal Asset Management Planning Regulation – Nothing new to report

- The Government of Ontario's new municipal asset management planning regulation (O. Reg. 588/2017 under the Infrastructure for Jobs and Prosperity Act, 2015) came into effective January 1st.
- New municipal compliance requirements will be phased-in over 6 years and in full effect July 1, 2024

#### Ontario Long Term Infrastructure Plan (LTIP) - Nothing new to report

- CEO has played an active role in developing portions of the LTIP with provincial officials
- CEO will be working with officials to develop and implement means for effective execution of the plan, facilitating fulfillment of Ontario's infrastructure initiative over the coming years
