1. Call to Order and Opening Remarks

2. Report from Manager, GLP Programs

- Take Your MPP to Work Days –one was held in Sudbury at SnoLab on March 15, 2019. Another
 is in the works at the Windsor GM plant.
- GLP meeting activity report –There is a total of 51 MPP meetings/interactions as of April 31st, 2019. Eight were in-constituency meetings.
- The Western Region GLP Academy was held in Chatham on May 11th, 2019. Rick Nicholls, MPP (Chatham-Kent-Leamington) was a guest speaker. The training content was well received.
- Kingston chapter has volunteered to hold the Eastern GLP Academy on Nov 23.

3. Report from Partners

Engineers Canada:

No representative present. Jeannette Chau reported that Rakesh Shreewastav has completed his term with Engineers Canada and has stepped down. He is therefore no longer their representative on the GLC. Engineers Canada has been contacted regarding his replacement, however this is being put on hold until they finish their operational review of their committees.

OSPE: Jerome James

A successful OSPE MPP reception was held in April. OSPE has launched a new report at the reception:

Howard Brown suggested that the Radiohead issue is an area of opportunity for PEO to raise profile with Premier's office.

Also, should look at how PEO can position itself on how to reduce red tape, as that is the focus of the present government.
