### 3. Partner reports

OSPE - The OSPE Queen's Park Day MPP reception will be held on March 8th.

**ESSCO -** The ESSCO FYIC (First Year Integration Conference) was held the weekend of February 5<sup>th</sup>. Jeannette Chau gave a presentation on PEO and licensing requirements.

**CEO** – There is a stakeholder survey on the Construction Lien Act. The review has been extended to March 31<sup>st</sup>. The key issue is around prompt payment.

**Engineers Canada** – Engineers Canada Contact Day to meet MPs and educate them about the role of Engineers Canada, professional engineers, and the role we play, is scheduled to take place on March 21<sup>st</sup>.

#### 4. Sub-committee reports

**Regulatory Issues update** – Several GLP Info Notes were being worked on. Jeannette is holding back the one on Continuing Professional Development as the name will probably change. Questions as to why an Info Note is being developed for the Infrastructure Resilience Professional certification as it is not a regulatory item. The draft Info Note on the Building Code was distributed to the GLC at the Jan 29<sup>th</sup> meeting. Howard had suggested the value of adding a quote to provide context. The Info Note will be distributed back to the sub-committee for on-line review and suggestions.

**GLP Chair Engagement** – a quarterly GLP chair call will be scheduled before the end of March.

**Take Your MPP to Work Day** – Gila Martow, MPP has expressed an interest in attending a PEO Take Your MPP to Work Day. The Willowdale chapter GLP chair has been notified.

**GLC conference/Queen's Park Day** – the sub-committee is currently investigating venue location options to hold the GLC conference on October 26, 2016
