9.0 Regulatory Issues sub-committee update.

- Darla Campbell updated the GLC on the November 10, 2015 Regulatory Issues Sub-committee
 meeting. PEO's town halls on "Implementing the Elliot Lake Recommendations. You talk. We listen."
 hosted by President Thomas Chong have been well attended. At the West Central Region town hall
 both Darla Campbell and Jeannette Chau were in attendance. A flyer had been distributed title
 "Compulsory "Professional Development" bureaucratic, costly, and ineffective" which had set a
 negative tone at the beginning of the town hall.
