## 4. Business Arising from the Minutes

#### (a) Monitoring in the Experience Guide

The Committee reviewed the PEO Guide to the Required Experience for Licensing and the Professional Standards Committee Draft Guideline titled "Assuming Responsibility and Supervising Engineering Work"

The Committee agreed that the main issue was with item 5 in Section 2.5.2 of the Experience Guide. Discussion ensued.

**Motion:** It was moved by Barna Szabados and seconded by Santosh Gupta that the suggestion to remove item 5. subsections i, ii,and iii under section 2.5.2 from the Experience Guide be referred to the ERC for peer review and endorsement.

## (c) Financial Credit Program

George Comrie discussed referred to the concern raised at the past AGM regarding the availability of the Financial Credit Program (FCP) to applicants with refugee status. This matter has been referred by Council to the LIC. He noted that LIC had earlier commenced a review of the overall value of the program, as well as its applicability to applicants on student visas.

Michael Price noted that the FCP had originally been approved by Council in 2007. The FCP applied to individuals who were either (i) CEAB graduates who applied within 6 months of graduation, or (ii) immigrants to Ontario who applied within 6 months of landing in Canada. In all cases the applicant also had to submit proof of Canadian citizenship or permanent residency for both cases, as well as transcripts that indicated that they had at least a Bachelor Degree in Engineering. In 2010 Council removed

the residency requirement for P. Eng. Licences, but the residency requirement was not changed for the FCP.

An issue was also brought forward by the Universities that students with International Visas are being rejected because they are not permanent residents.

The Committee referred to a document provided by Michael Price regarding the number of CEAB and Non-CEAB applications and licences approved over a 100-year period. Discussion ensued.

Michael Price suggested that PEO should contact Engineers Canada to determine how many graduates there are from CEAB programs in Ontario each year. This can be used against the number of applications to establish a baseline.

**Action:** George Comrie to initiate a conversation with Registrar McDonald to discuss the seamless transition data and the annual number of Ontario CEAB graduates.

It was decided by the Committee to leave the current roster as is and to amend it at the next meeting.
