1. Need for PEO Action

On November 15, 2018, President Brown, P.Eng., received the following request from Dr. Kathy Tarnai-Lokhorst, P.Eng., President, Engineers and Geoscientists BC:

Fellow Presidents,

As you may know, Engineers and Geoscientists BC is going through very challenging times with the introduction in our legislature of Bill 49, The Professional Governance ACT. There are some good features in this ACT such as mandatory CPD, Corporate Regulation and council bylaw authority. However, there are others of grave concern; especially granting practice rights to technologists and the requirement for all members to make declarations of competency and conflict of interest for all projects prior to starting work. Furthermore, the unlimited power and lack of accountability of the superintendent of this office is potentially a serious concern.

One of our members, Dr. Ralph Sultan, P.Eng., is an MLA and he too is very concerned about this Bill. In the email attached, he is asking to receive letters of concern that can be read out in the house to support Engineers and Geoscientists BC. Engineers Canada has provided such a letter as has our director to Engineers Canada, Russ Kinghorn, P.Eng., FEC, FGC (Hon.). Their letters are also attached for your reference.

We would greatly appreciate it if you could provide a letter from your association. We do believe that there is every possibility that if this kind of change is implemented in BC, it can easily spread across the country, and so your support may ultimately help prevent that from happening.

The Bill has passed first and second reading and is progressing at a rapid speed through the House and therefore this request is one of some urgency.

Please don't hesitate to contact me if you have any questions. I look forward to meeting you all at the next Engineers Canada board meeting.

Re: Bill 49—2018: Professional Governance Act

Dear Minister Heyman,

On behalf of the Council of Professional Engineers Ontario (PEO), I am writing to you regarding the proposed practice rights for technologists included in Bill 49—2018: *Professional Governance Act.*

PEO, like Engineers and Geoscientists BC, is mandated by provincial legislation to regulate and advance the practice of professional engineering in the public interest. In Ontario, engineers and technologists enjoy a positive and collaborative relationship as evidenced, most recently, by the addition of a regulation under the *Professional Engineers Act* that established the licensed engineering technologist (LET) class of limited licence. Since 2015, a limited licence holder who is also a certified engineering technologist (C.E.T.) with the Ontario Association of Certified Engineering Technicians and Technologists (OACETT) can apply for this class of limited licence and, if approved, use the protected title of licensed engineering technologist and LET designation.

The LET class of limited licence provides a pathway for qualified members to practise professional engineering within a defined scope of practice. Holders of limited licences are governed and regulated by PEO to the same standards as professional engineers. Along with the creation of this new class of limited licence, PEO changed its certificate of authorization (C of A) to permit limited licence holders to be responsible for engineering services offered or provided to the public within the limitations of their licences. This meets marketplace and practitioner needs without compromising public safety and welfare.

I offer these insights to demonstrate how existing statutory instruments—the *Professional Engineers Act* and the C of A in this case—can be used to effectively meet the needs of engineers, technologists, legislators and the public. As your government considers the development of policy and regulations under the proposed *Professional Governance Act*, I encourage you to consider the merits of having one regulatory body to govern professional engineers and technologists. Affixing a licensing regime for technologists to an existing and proven entity such as Engineers and Geoscientists BC may produce the same successful model that efficiently regulates these professions in Ontario.
