MATTERS ARISING FROM THE MINUTES

R. Martin reviewed the action items which were all completed.

There was a brief discussion regarding a CESC recommendation to reinstate experience requirements in future elections for the offices of Vice President and President. Past President Comrie advised that this proposal was referred to the Legislation Committee for review in accordance with PEO's legislative change protocol. The Legislation Committee saw no issues with this. The next step would be for the CESC to bring this forward to Council at a future meeting.

R. Martin advised that the all candidate meeting questions will be posted on PEO's website as soon as they are approved by the CESC which is a change from previous years.

The committee discussed and made changes to the proposed questions for the 2018 All Candidate meetings.

It was suggested that the moderator have a few relevant situational questions regarding PEO as a regulator. The point is to demonstrate the candidate's depth of knowledge about PEO and their ability to think on their feet.

#### **IPSOS REID SURVEY REVIEW**

The results of the 2013 Ipsos Reid Council Elections Membership Survey was provided to the committee for information as requested at its October 24, 2017 meeting. The purpose of the request was to see if the survey provided any information to indicate why candidate participation is low. R. Martin referred to page 46 of the survey which dealt with attitudes towards PEO Council noting that this did not provide any real specifics regarding this issue.

- H. Wojcinski suggested that a separate survey regarding the desirability to run for PEO Council could be useful and that this could be part of the Governance Review to determine what a reasonable commitment would be to encourage, for example, mid-career engineers to run for election.
- H. Wojcinski referred to the new template which gives standard information on each candidate and that this may be a good reason for revisiting that template. She noted that education is required to inform members why it is important to vote.
- D. Smith advised that Communications is creating different banners with different messages to post and highlight that not only is voting important

incorporated into banners which will be rotating on the website as well as included in all of PEO's social media accounts. **CANDIDATE SEARCH** The list of 2018 candidates for PEO Council as of November 21, 2017 was provided to committee members via email and hard copy. i. **CESC Reports** G. Comrie, J. Obaid and W. Wojcinski provided an update regarding their outreach efforts. ii. **RESC Chair Reports** There are three candidates for Northern Regional Councillor which is a very improvement from previous years. I. Bhatia, L. Hidalgo and W. Turnbull provided updates. It is expected that additional candidates will be bringing their names forward for most of the positions, including Vice President and Presidentelect. There was some discussion regarding communication with unsuccessful candidates from previous elections noting that competencies should always be in the forefront.
