INTERPRETATION OF NOMINATION REQUIREMENTS FOR VICE-PRESIDENT POSITION

A summary of email communications between R. Linseman and A. Elliot, Chief Elections Officer, was provided in the meeting package as Appendix B. Nomination Forms were submitted in support of R. Linseman for the position of Vice-President; however, since there was no nominator from the West Central Region, his candidacy for the 2020 PEO elections was not accepted. R. Linseman advised that he disagreed with the CEO's interpretation of the legislation that candidates for at-large positions must have a nominator from each of the five regions. R. Linseman's interpretation is that there has to be a minimum of 15 nominators and

they <u>can</u> come from any of the five regions.

B. Dony stated that the legislation states that "14. (1) A Member may be nominated for election to the Council as president-elect, vice-president or a councillor-at-large by no fewer than fifteen other Members, including Member residents from each Region. O. Reg. 157/07, s. 5."

D. Abrahams, PEO Legal Counsel, was consulted and agreed with the logical and purposive interpretation that staff and the Chief Elections Officer have applied to this situation.

R. Linseman has accepted the fact that he did not meet the requirements; however, he has asked the CESC to consider changing the Regulations to be more clear and that the requirements of each of the five regions be revised for the at-large positions.

Following discussion it was agreed that R. Linseman's concern would be added to the CESC Issues Report that will be brought before Council at it's June 2020 meeting. This will be communicated to R. Linseman by A. Elliot, Chief Elections Officer.
