I believe PEO has to put more emphasis on the emerging discipline portfolio. At the moment, we have not kept pace with the rapidly changing technological landscape. In order to continue to protect the public, we need to improve our work in this area, particularly within the licensing processes. As a Councillor, I will work with the team to ensure the policies and support are in place for Staff to make improvements.

Over the last 13 plus years volunteering with PEO and working with other PEO volunteers, I have an excellent understanding of the role of Council and the roles of individual Council members. To be clear, as a member of Council, I would be 1 vote amongst the many. I cannot promise to make broad sweeping changes. What I can promise is that I will work with Council to ensure that decisions are based on facts and not opinions. I will review information and come to the table prepared for effective debate.
