PEO firmly and impartially adheres to its legislated requirements in pursuit of regulatory excellence.

**PROFESSIONALISM**—PEO operates in a professional manner by demonstrating competence, impartiality and reliability.

**TEAMWORK**–PEO achieves its goals through effective teamwork and collaborative partnerships among its staff, between its staff and volunteers, and with other bodies involved in the practice of professional engineering.

# MY GOALS AS PRESIDENT-ELECT ARE:

- Guarantee the continued viability of Chapters by making them more relevant as part of the regulatory practice by ensuring that they act as a local arm of the regulatory committees.
- 2. Continue the Government Liaison Program as a required connection between the Government and a premier regulator.
- 3. Implement the recommendations of the regulatory review in a thoughtful manner that will ensure the identity of PEO as a premier regulator is not lost.
- 4. Propose that fee increases are geared to inflation to guarantee the future viability of PEO as a regulator and to avoid large jumps in our fees in the future.

- Guarantee that PEO has a BALANCED budget by ensuring that all staff and volunteers are concentrating on PEO's core values and mandates.
- Revisit the PEAK program and the idea of continued professional development to meet the request of the government to have mandatory continued professional development.
- 7. Reduce the experience requirement for graduates from 4 years to 2 years to greater influence the regulation of our profession by capturing more graduates who are completing engineering.
- 8. Create a Committee of Past Presidents that will be maintain the corporate history of PEO and be consulted on important strategic issues.
- 9. Better manage the relationship between PEO and OSPE with the goal of having every PEO member also a member of OSPE.

10. Concentrate our enforcement efforts where there is the highest need by creating a yearly "blitz" enforcement effort.
