1. Call to Order and Chair's Remarks

The meeting was called to order by the Chair, Ramesh Subramanian at 10.31 a.m. He asked the Committee to observe a moment of silence for the massacre (The École Polytechnique massacre, also known as the Montreal massacre) of fourteen women in 1989.

5. Chair's Report

David Kiguel noted that Jim McConnach of ERC, will also be receiving the PEO Order of Honour award in April 2020.

There was an e-mail from CEAB noting that there is an open call for a Member-at-Large to sit on their Accreditation Board.

6. Staff Report

6.1 Mandatory PEO Volunteer Training Reminder

Moody Farag also followed up with the Chair's report to remind the ARC to submit their expense reports by December 12, 2019.

Mandatory Volunteer Training – Moody Farag informed the Committee that this training program is an obligation and that PEO does not have an option and that it is important to do the training. A completion list will be provided to the Committee by the end-of-the-year.

6.3 LIC Request to Develop a Process to Assess Tech Exams

7.4 PPE October 16, 2019 additional sitting results

Anna Carinci Lio provided the ARC with a hand-out regarding the stats of an additional sitting of the PPE on October 16, 2019 at PEO offices, which occurs three-times a year. Fourteen failed at their 1st sitting, and two failed at their 2nd sitting.

8. Procedural and Related Matters

8.1 Licensing Committee (LIC) Update

Barna Szabados provided an update from the Licensing Committee (LIC) of December 5, 2019.

There were two major items of importance.

- a) The Licensing Committee (LIC) has been working on an urgent item that they have identified, is the one-year Canadian experience under the supervision of a "P.Eng." There are many applicants that cannot practically meet this requirement. The Committee is working on trying to get something called an "inspection", the original description of a "monitor". The principle is to find a solution, which does not require an *Act* change or a Regulation change.
- b) The Ontario Fairness Commission (OFC) sent an e-mail on November 4, 2019 in response to a request for clarification of their original letter sent to PEO in June, regarding technical exam(s). The e-mail was presented at the November 8, 2019 meeting.

The Chair noted that the ARC will strike a working group for technical exams to provide instruction on how to prepare an exam. ARC members who have volunteered to be part of this working group are Leila Notash (Chair), Waguih ElMaraghy, Barna Szabados, Al Stewart, Judith Dimitriu and Roydon Fraser.

8.2 Canadian Engineering Accreditation Board (CEAB) Update

The last meeting of the CEAB was in September and the next one will be in the first week in February 2020.

Six Ontario universities are supposed to go through an accreditation visit this year. Five have gone through accreditation visits: Conestoga, Lakehead, Carleton, Laurentian and Waterloo.

9. New Procedural Matters for Discussion

9.1 Canadian national entry-to-practice examination

10. Other Business

10.1 <u>Discussion of a Candidate (Undergraduate Degree and a Master's Degree with Two Failures)</u>

Leila Notash asked for direction from the ARC on a particular candidate. "What is ARC's position when there have been many failures."

Roydon Fraser suggested the following:

- 1. That, ARC prepares a document for the Registration Committee to follow.
- 2. That, if you have a red flag, that you assign Confirmatory Exams.
- 3. That, when you add up the risk factors, you don't avoid the evidence.

It was suggested by Waguih ElMaraghy that this should be a standing item on the agenda under Item 8. called, "Applicant File Decisions" and Moody Farag's name will be on the agenda for this item.

11. ERC Report

David Kiguel noted that there has not been an ERC meeting since the last ARC meeting.

The Chair of ERC was acclaimed for a third term. The Vice Chair election ends today by e-mail.

The next ERC meeting is on December 20, 2019. There was going to be some training and the sub-committee met and it has been postponed until next year.

They also have on the agenda Dan Abrahams of PEO, who will be speaking on The Policy on Eliminating Bias.

He also received the ERC data compliance of the government training. Twenty percent of ERC members have completed the training.

Councillor Leila Notash will attend the December 20, 2019 lunch and business meeting on behalf of the ARC Chair, Ramesh Subramanian, who is not able to attend due to other commitments and the Vice Chair, Waguih ElMaraghy will be away overseas.

David Kiguel suggested that Leila Notash contact Daniel Mandefro to advise him of her attendance at the ERC meeting.
