Environment, Conservation and Parks Minister **Jeff Yurek**, MPP (Elgin-Middlesex-London) announced Ontario's first ever climate change impact assessment on August 14. It is being led by the Climate Risk Institute. As part of the study they will be reviewing climate data, land use patterns and socioeconomic projections.



PEO GLP REP SHARES HIS INSIGHTS ON THE IMPORTANCE OF THE GLP

This week's interview is with PEO Grand River Chapter Government Liaison Program representative **Harmail Basi**, P.Eng.

1. What is your experience dealing with the political process?

My family has been involved in the political process for at least three generations and covers four continents, Australasia, Asia, Europe and the Americas! It was natural for me to want to get involved when I moved to Canada in 1991.

In 2004, I had the privilege of being appointed to the Board of Ontario Trillium Foundation, which invests over \$125 million annually in volunteer and not-for-profit organizations across Ontario. During my six years in this role, I had the opportunity to recommend investments of over \$5 million in over 100 not-for-profits. I also served as the Vice Chair of the Audit and Finance Committee for three years.

Over the years, I have worked with a number of engineering organizations in the nuclear, environmental and infrastructure sectors. I am now a project manager engaged with helping the Canadian Nuclear Laboratories (CNL) remain world class for generations to come.

As well, I have been involved with the PEO Grand River Chapter Government Liaison Program Committee for over 11 years. I have participated in PEO Queen's Park Days, Government Relations Conferences, Academies and Congresses and events with local MPPs in our chapter and across Ontario.

2. Why did you get interested in government liaison activities at PEO?

It was an opportunity to engage in the regulatory policy process of the engineering profession. It was a chance to ensure that professional engineers were front and centre of decisions made in the legislature, for the benefit and public safety of Ontarians.

3. What do you think the biggest challenges are of the GLP?

PEO needs to continue to focus on its regulatory role. We are no different than the legal and medical professions, where the safety of the public remains our prime directive.

It is also important for PEO to continue to engage with MPPs, which has become even more difficult now with COVID.19 We need to continue to make the public aware of our regulatory role on specific topics, things that matter to the public at large.

4. What do you think the biggest opportunities are for the GLP?

I think there is a real opportunity to continue to build strong relationships with other regulated professions. As well, we should use this time to continue to engage with all 124 MPPs, and ensure we are on their radar when it comes to decision making.

Informing the public of our regulatory work is something the Grand River Chapter, under the leadership of **Gabe Tse**, P.Eng., has done for years.
