

(WINDSOR) - Former PEO Government Liaison Committee member **Andrew Dowie**, P.Eng. has been acclaimed as the PC candidate for the riding of Windsor-Tecumseh in the 2022 provincial election.

The nomination meeting was held virtually on November 25.

Mr. Dowie has served as a Councillor for the Town of Tecumseh (Ward 1) since 2014.

He is a former GLP Chair of the PEO Windsor-Essex Chapter and was a founding member of the PEO Government Liaison Committee.

He was also the first recipient of the G.Gordon M. Sterling Engineering Intern Award in 2010.

"From the time I began my engineering career in 2001, my work has included finding workable, practical solutions within defines constraints," said Mr. Dowie. "While politics has little in common with the applied sciences, using problem solving skills is universal."

He will be running against the current incumbent **Percy Hatfield** (NDP).

PEO COUNCIL APPROVES NEW GOVERNANCE AND ANTI-RACISM INITIATIVES

As reported in last week's GLP Weekly, PEO held their 537 Council meeting on November 20.

The meeting was held online and was chaired by PEO President **Marisa Sterling**, P.Eng. In her opening remarks, President Sterling told Council of her participation in the successful Government Relations Conference, held last month, and hosted by the PEO Government Liaison Committee.

The following items were discussed:

- Application of the regulatory Activity Filter, of which 18/93 items were labelled as 'Governance'.
 A breakdown was provided on which items were considered core regulatory.
- Council approved the adoption of 11 governance directions, including one that PEO Council members will only serve on board (governance) committees.
- An analysis of open P.Eng. Licence applications and digitization project to convert paper files to electronic versions.
- Professional Standards Committee to form a Professional Engineers Providing Acoustical Engineering Services in Land-Use Planning subcommittee

NEW PEO COUNCILLOR SHARES HIS THOUGHTS ON THE VALUE OF THE GLP

(KENORA) - This week's interview is with PEO Lieutenant Governor Appointed Councillor **Scott Schelske**, P.Eng.

1. What is your experience dealing with the political process?

I have virtually no experience with the political process, as I didn't even become a Canadian citizen until 2017 (although I immigrated to Canada in 1966). My family moved back to the U.S., but I stayed, having married a Canadian.

However, I decided to keep my options open to return south until my retirement, when I decided to remain in the 'True North" and become a citizen. I voted for the first time in my life in the 2018 Ontario election.

2. Why did you get interested in government liaison activities at PEO?

In 2004, PEO was considering folding the Lake of the Woods Chapter due to years of inactivity. Five of us at the Lake of the Woods Chapter accepted an invitation to meet with PEO Council Executives and agreed to attempt to restart the Chapter.

We divided up the executive duties and since I had the most flexible work schedule, I agreed to take on any role needed to fill in the gaps. When the Government Liaison Program (GLP) started and 'GLP Rep' became a Chapter position, I accepted it along with my other three Chapter Executive positions of Secretary, Kenora Area Representative and Education Coordinator.

That being said, I was always very interested in the GLP from the outset, having been working for a Civil Engineering firm that was mainly involved in commercial work. I had to start taking the Building Code exams because the Ontario Government didn't exempt engineers from having to take them, similar to what was done to the architects. Therefore, the value of the GLP and consulting with MPP's before legislation was passed became immediately apparent.

3. What do you think the biggest challenges are for the GLP?

With the changes coming from PEO Council, it's important that the GLP remain intact at PEO to keep MPP's abreast of developments.

4. What do you think the biggest opportunities are for the GLP?

Ontario has an enormous land mass and has a huge diversity in climate, topography, people, industry, employment opportunities, etc. It is extremely difficult for groups to relate to each other and to make everyone work in unison toward any sort of common goals. PEO has an opportunity to connect with MPPs through our volunteers all across Ontario and ensure all our opinions and interests as the regulator of the profession are being heard by MPPs.
