1. OPENING OF MEETING

In the absence of the Chair, the Vice-Chair called the meeting to order at 6:00 p.m., with six members of the Committee in attendance. Consequently, quorum was attained.

1.1 Approval of the Agenda

The agenda was approved as written.

2. MINUTES OF PREVIOUS MEETING AND ISSUES ARISING FROM MEETING

2.1 Approval of Minutes of October 6, 2020 Meeting

The Minutes of the October 6, 2020 meeting were approved as written.

2.2 Action Items of October 6, 2020 Meeting

Staff made reference to the Action Items Log of the October 6, 2020 meeting, and reported as follows:

- <u>Guideline for Performance Audits and Reserve Fund Studies for Condominiums</u>: Staff to follow up with the Ministry of Municipal Affairs regarding the status of mandatory structural condition assessments.
- <u>Coordinating Licenced Professional Subcommittee</u>: Staff provided a copy of the latest version of the draft bulletin to the PSC members for review and comments.
- <u>Professional Engineering Practice Guideline</u>: Staff provided a copy of the latest draft guideline to the PSC members for final review and feedback.

2.3 New Members for PSC

Staff advised that F. Wong and R. Jones have reached their ten-year term limit on the Committee; however, the PSC has not replaced N. Pfeiffer, H. Swan, and J. Catania. Consequently, the PSC approved a motion to request an extension for F. Wong and R. Jones as members for one more year.

Election of a new Chair and Vice-Chair for the PSC will be discussed and decided in the future.

Action: PSC subcommittee members to provide staff with the CVs of

people who are interested in becoming members of the PSC.

The Vice-Chair suggested that the PSC have available a list providing each instance where "professional engineer" occurs in provincial legislation for reference when the PSC is reviewing proposed guidelines and standards, and for PSC subcommittees' use when writing draft documents.

3. GUIDELINES

3.1 Guideline for Performance Audits and Reserve Fund Studies for Condominiums

The subcommittee met on October 13, 2020. An invitation-only public consultation will take place in the near future, starting from the second week of November 2020.

3.2 Use of Seal Guideline

A first draft of the guideline is now available for the PSC to comment on.

3.3 MECP - Professional Engineers Providing Engineering Reports under O. Reg. 1/17 (ESDM and AAR Reports)

A meeting of the subcommittee was held on October 15, 2020 to review the comments received from the public consultation. A version of the draft guideline should be ready for PSC approval before the end of the year.

The letter received from OSPE included in the agenda package advocates for changes in the *Environmental Protection Act*. It was suggested that the Chair of the PSC forward a copy of this letter to PEO's President.

Action:

Staff, with the assistance of Council Liaison L. MacCumber, to prepare a memo to PEO's President regarding the letter received from OSPE, which is to be approved by the Chair of the PSC.

3.4 Coordinating Licensed Professional Joint Subcommittee

The Practice Bulletin is currently being reviewed by the subcommittee for final approval.

3.5 Guideline for Pre-Start Health and Safety Reviews

The subcommittee met on November 9, 2020. The first draft of the guideline should be available prior to year end for PSC and Review Network comments.

3.6 Professional Engineering Practice Guideline

This guideline is ready for final PSC approval.

Two engineers from the National Research Council will write a practice article on this matter.

A practice article regarding site visits during COVID-19 and remote site supervision will be published in the near future.

4.4 Systems Engineering Filter

A PSC member and staff developed a decision matrix, which was included in the agenda package. R. Jones made a brief presentation on the updated contents of the Systems Engineering Filter decision matrix.
