PEO SWEARS IN NEW PRESIDENT AT 99TH ANNUAL GENERAL MEETING

PEO President **Christian Bellini**, P.Eng., was sworn in as the 102nd PEO President at the association's AGM on May 15.

He said that he was particularly grateful to the PEO Council for its work in developing a governance road map in helping PEO better focus on its regulatory mandate.

"...I am excited about the prospect of wrapping up the governance project this year so we can really get on with the work of renewing and modernizing our regulatory structure," said President Bellini.

He is a principal at the engineering firm Blackwell, where he began his engineering career in 1995.

Over the years, he served on, and in some cases chaired, many of PEO's regulatory committees and task forces.

President Bellini closed his speech by acknowledging his gratitude towards his father by saying "I'd also like to take this opportunity to thank my father...for encouraging me to follow an engineering career, and for his tireless promotion of our profession."

Marisa Sterling, P.Eng., stepped down as the 101st President of PEO and gave the PEO Chain of Office to Mr. Bellini at the AGM.

Ms. Sterling was the eighth woman to serve as PEO President. Notably, her father, **Gordon Sterling**, P.Eng., served as the 82nd PEO President.

Prior to stepping down, she spoke passionately about what PEO's successes were from the past year, reinforcing President Bellini's emphasis on a greater focus on PEO's regulatory mandate.

"The succession of presidencies from my predecessor Nancy Hill, to incoming president Christian Bellini is one example where we have all worked collegially to add more steps towards the same future path," said Ms. Sterling.


A new PEO Council was sworn in at the PEO AGM on May 15 including six new Councillors:

ONTARIO ENVIRONMENT INDUSTRY ASSOCIATION HOSTS EVENT WITH TWO MINISTERS



Minister of the Environment, Conservation and Parks, **Jeff Yurek**, MPP (Elgin-Middlesex-London) (left) and **Vic Fedel**i, MPP (Nipissing), Minister of Economic Development, Job Creation and Trade (right) were guest speakers at the Ontario Environment Industry Association (ONEIA) event, EvolutiON on May 12 and 13.

The Ontario Environment Industry Association (ONEIA) hosted their 2021 Environment and Cleantech Business + Policy Forum Conference, EvolutiON, from May 11 to 13.

Speakers at the event included:

- Environment, Conservation and Parks Minister **Jeff Yurek**, MPP (Elgin-Middlesex-London) who spoke about the Ministry's "role in recovery and rebuilding the Ontario economy post-pandemic."
- Economic Development, Job Creation and Trade Minister Vic Fedeli, MPP (Nipissing), who on Twitter said that it was "great to discuss how Ontario's environment and cleantech biz can take advantage of new markets, opportunities and thrive in the emerging sustainable economy."

Both Ministers have been regular participants in both their PEO Chapter and Queen's Park events. PEO Government Relations Consultant **Howard Brown** was a guest speaker with Ministers and MPPs at the 2019 ONEIA Conference, which looked at emerging public policy issues.

It is important for PEO Chapters to invite MPPs to their own local events so that they can become familiar with the work that engineers do, and to raise the profile of PEO and its regulatory role.

PEO hosted its 99th Annual General Meeting on May 15.

Over 600 people participated online, including over 400 voting PEO members. This was the largest number of attendees at a PEO AGM in over a decade.

Attorney General **Doug Downey**, MPP (Barrie-Springwater-Oro-Medonte) participated in the AGM. He was introduced by 2020-21 President **Marisa Sterling**, P.Eng., who acknowledged their shared background. They served in their youth as Pages in the Ontario Legislature.

He congratulated PEO for their successful year in managing the business of the association with the challenges of Covid-19.

The Attorney General also thanked engineers for harnessing technology to keep people safe, recognizing their creativity and adaptability throughout the pandemic.

He said he had a special fascination for the profession growing up, having had members of his own family working in the sector.

He also complemented PEO Council on doing the important work in moving changes forward towards implementing mandatory continued professional development.

The Attorney General said he was also pleased that the Government was able to proclaim a number of changes to the *Professional Engineers Act*, some after a decade, that helped PEO's ability to regulate the profession.
