MPP Harden was elected to the Legislature in 2018. He is the NDP Critic for Accessibility and Persons with Disabilities.


Prior to being elected, he was a researcher at the Canadian Federation of Students.

# REVIEW OF PROFESSIONAL GOVERNANCE ACT ADVOCACY RESTRICTIONS COMPLETED BY ENGINEERS AND GEOSCIENTISTS BC



Engineers and Geoscientists BC completed a review of Professional Governance Act advocacy restrictions as reported on their website on October 6.

VICTORIA, BC - Engineers and Geoscientists BC Council and staff recently completed a strategic review of over 20 programs and activities against the 'restriction on certain advocacy activities for the regulators' under the *Professional Governance Act* (PGA) on October 6.

Here are excerpts from the release:

"The review determined that Engineers and Geoscientists BC's core operations and most other programs can continue, while some require modest changes to come into compliance with the PGA..."

"...With the review of non-regulatory programs completed, Council considered the question of establishing a separate advocacy body. Council considered the need to maintain its organizational capacity during this period of significant transition to new legislation, the need to maintain our strong culture of volunteerism, and the significant challenges of planning for an organizational restructure that may tax the organization beyond its capacity.

With these considerations in mind, and given the relatively small impact to the programs currently in place, Council determined that further considering and potentially establishing a separate advocacy body at this time was not in the organization's interests."

#### TOM RAKOCEVIC, MPP



Almost 60 GLP Chairs and Reps participated as well as former PEO President, current PEO Etobicoke Chapter GLP Chair and Whitestone mayor **George Comrie**, P.Eng., former PEO Councillor and current GLC member **Warren Turnbull**, P.Eng., and PEO Manager, Government Liaison Programs, **Jeannette Chau**, P.Eng.

Discussed at the meeting were GLP Representative certification status updates and new GLP Info Notes including:

Representatives were informed that the Legislature has reconvened on October 4. Chapters may also now engage in in-person events, however on-line meetings are also effective and may be more easily arranged and are encouraged to continue.

Also discussed was how Take Your MPP to Work Days are opportunities for MPPs to see the work professional engineers do in the public interest, and to learn more about the role of PEO. The next call will take place on January 19, 2022.
