

# LABOUR MINISTER INTRODUCES LEGISLATION THAT WOULD IMPACT REGULATED PROFESSIONS



Bill 27, the Working for Workers Act was introduced by Monte McNaughton, MPP (Lambton—Kent—Middlesex) Minister of Labour, Training and Skills Development on October 25. PEO Past President Marisa Sterling, P.Eng. spoke about the matter with CBC on October 21.

**Monte McNaughton**, MPP (Lambton—Kent—Middlesex) Minister of Labour, Training and Skills Development introduced <u>Bill 27</u>, the <u>Working for Workers Act</u> in the Legislature on October 25. Here is an excerpt from Schedule 3 of the bill which proposed to amend *The Fair Access to Regulated Professions and Compulsory Trades Act*, 2006:

- Regulated professions are required to ensure they comply with any regulations respecting English or French language proficiency testing requirements.
- Regulated professions are also prohibited from including Canadian experience requirements as qualifications for registration unless an exemption from the prohibition is granted.
- Compliance orders may be issued if a regulated profession imposes requirements that are prohibited under the Act.

PEO Past President **Marisa Sterling**, P.Eng. spoke about the matter on a radio interview on CBC's Metro Morning and on a CBC TV interview as a representative of both PEO and in her role as Assistant Dean and the Director of Diversity, Inclusion and Professionalism at the University of Toronto on October 21.

Ms. Sterling said, "We're trying to remove barriers so that people can be their fullest in society...I think that there are many elements to look at this systems change. What are systemic biases and barriers that may be affecting internationally educated professionals to be able to be fully productive here in Ontario?".
