MARKHAM - Kathleen Wynne, MPP (Don Valley West) met with PEO East Toronto Chapter on December 6. MPP Wynne served as Ontario's 25th Premier from 2013 to 2018. She was first elected to the Legislature in 2003 and has announced her plan to retire effective as of the June 2, 2022 provincial election.

The meeting was the first opportunity for **Tracy Garner**, P.Eng. to meet formally with MPP Wynne in Ms. Garner's new capacity as the Chapter's GLP Rep for MPP Wynne's riding. They have known each other for a number of years and this was an opportunity to educate MPP Wynne on Ms. Garner's new responsibility. Also attending the meeting were P.Eng.Chapter GLP Chair **Omid Sadeghi**, P.Eng. and PEO Government Relations Consultant **Howard Brown**.

## HON. CHRISTINE ELLIOTT, MPP

Hon. **Christine Elliott** MPP, (Newmarket-Aurora) was first elected to the Ontario Legislature in 2006 for the riding of Whitby-Ajax. She then served as the MPP for the riding of Whitby-Oshwa from 2007 to 2015. Afterward, she was appointed as Ontario's Patient Ombudsman.

In 2018, she was elected as the MPP for the riding o Newmarket-Aurora and currently is the Deputy Premier and the Minister of Health, which she has served in since her election.

Minister Elliot has been overseeing the response to the COVID-19 pandemic in Ontario.

On joining the Legislature, she was a regular participant in PEO events including a meeting at PEO headquarters and Queen's Park Days.

She has always expressed a great deal of interest and support for the Government Liasion Program (GLP).

### FRANCE GÉLINAS, MPP

**France Gélinas**, MPP (Nickel Belt) was first elected to the Ontario Legislature in 2007.

She is the NDP Critic for Health and Long-Term Care and Francophone Affairs.

MPP Gélinas has a background as a physiotherapist. She has served as the Executive Director of the Community Health Centre of Sudbury, on the United Way's Citizens' Advisory Panel, and served as the President of the Francophone Reference Group of the Northern Ontario School of Medicine.

HOLLAND LANDING - Minister of Transportation and Francophone Affairs **Caroline Mulroney**, MPP (York-Simcoe) met with PEO York Chapter Rep **Dale Kerr**, P.Eng. on December 3. Minister Mulroney previously served as the province's Attorney General from June 2018 to June 2019 and met with PEO in 2018.

Also attending the meeting was the Minister's Executive Assistant, **Mary-Lynn Seeley** and PEO Government Relations Consultant **Howard Brown**.

Ms. Kerr discussed with Minister Mulroney the role of other engineering associations, the history of the Government Liaison Program (GLP), and PEO initiatives such as the regulatory review. The Minister was interested in a number of issues as she has over 300 engineers working in her Ministry. She was also interested in the 30 by 30 initiative which aims to increase the number of newly licensed engineers who are women to 30% by the year 2030.

The Minister said, "PEO does a good job as the regulator of professional engineers in the public interest and the Government Liaison Program, which matches one representative to each riding, does a good job of supporting PEO's mandate."

Ms. Kerr told the Minister that she would make her aware of any upcoming Chapter events coming up next year such as licensing certificate ceremonies. Ms. Kerr said, "It was a very productive meeting, and I thought it was a valuable interaction."

The Minister also mentioned that her mother studied engineering and that she has always had an interest in the profession. It is important for PEO Chapters to maintain connections with their local MPPs to ensure that PEO's voice is heard. This was one of two MPP meetings that PEO has held in the last week.
