

Premier **Doug Ford**, MPP (Etobicoke North) announced on February 14 that the province will end proof of vaccination and lifting capacity limits as of March 1.

"Given how well Ontario has done in the Omicron wave, we are able to fast track our reopening plan," Premier Ford said.

"This is great news and a sign of just how far we've come together in our fight against the virus. While we aren't out of the woods just yet we are moving in the right direction."

He is the NDP Critic for Small business recovery and Reopening Main Street.


Prior to his election, MPP Arthur was the executive chef at local restaurant Chez Piggy and coached for the Queen's University rowing team.
