This is the second time that MPP Fraser has stepped in as interim leader for the party, as he was also appointed to the role following the 2018 provincial election.

Mr. Del Duca offered MPP Fraser best wishes in a tweet, saying "Congratulations to @JohnFraserOS on being selected to serve as Interim Leader of the Ontario Liberal Party. John will once again provide steady, thoughtful, decent leadership and I wish him all the very best."



# ENGINEERING DIMENSIONS PUBLISHES LEGISLATIVE UPDATES, 2021 ANNUAL REVIEW

In the July/August edition of PEO's bi-monthly publication, *Engineering Dimensions*, an article was published entitled, "PEO moves forward with FARPACTA changes". (*Fair Access to Professions and Compulsory Trades Act*)

The changes to FARPACTA include:

- Non-health professional regulators must eliminate the previously mandatory Canadian work experience component of licensing requirements, unless the regulators demonstrate that public health and safety are at risk.
- Decisions regarding licensure applications must be made within six months for 90 per cent of new applicants, and 30 days for applicants who have previously registered with another provincial or territorial regulator within the same profession.
- Protocols for continuing licensing processes during emergencies must be devised and implemented.



The July/August 2022 issue of Engineering Dimensions offers updates on changes PEO must make to comply with the Fair Access Profession and Compulsory Trades Act (FARPACTA.)

 Regulators must maintain updated reporting obligations to the fairness commissioner in order to demonstrate compliance with new licensing requirements and decision deadlines.

The full article is available on page 11 of the <u>July/August 2022 issue of Engineering</u> <u>Dimensions</u>.

Included in this issue of *Engineering Dimensions* is the PEO *Annual Review 2021*, a 16-page document entitled *Roadmap to Transformation*. On page 14, there is a section on the GLP which says: "The main objective of PEO's Government Liaison Program (GLP) is to ensure that government, PEO licence holders and the public continue to recognize its regulatory mandate, in particular its contributions to maintaining the highest level of professionalism among engineerings working in the public interest. The goal is to have the government view PEO as a partner and understand and support PEO's policy direction."

Prior to her election to the Legislature this year, MPP Dixon worked as both a federal and a provincial prosecutor. She worked in the Ministry of the Attorney General, both as a student and as an Assistant Crown Attorney after she was called to the bar in 2014. Additionally, she served as a Crown attorney in the Kitchener courthouse.

MPP Dixon holds a Bachelor's degree in Philosophy from University of Guelph, and completed her law degree at University of Ottawa.

#### MARY MARGARET MCMAHON, MPP

**Mary-Margaret McMahon** represents the Liberal Party in the riding of Beaches-East York.

Prior to her election to the Legislature, MPP McMahon served as a Toronto City Councillor for Ward 32 from 2010 to 2018. She also previously served as Director of Community at Sidewalk Labs, and worked for Toronto's Live Green Toronto project as a community animator. Additionally, she helped organize a farmer's market on the Danforth in Toronto.


