STRATFORD - PEO London Chapter GLP representatives met with the newly elected Perth-Wellington MPP **Matthew Rae** on September 9. Attending the meeting for the chapter were GLP representative **Steven Yu**, P.Eng., and London Chapter Chair **Manish Dalal**, P.Eng. Also participating in the call on behalf of the head office were Chapter Coordinator **Julie Hamilton** and PEO Government Relations Consultant **Howard Brown**. **Jacob Shuker** from MPP Rae's office was also in attendance.

Mr. Rae was familiar with PEO as he had worked with the former MPP **Randy Pettapiece** prior to his election.

The PEO delegation provided Mr. Rae with an update on PEO's regulatory mandate, as well as upcoming chapter activities and PEO initiatives. They explained that PEO's focus in the coming months will focus on two priority issues — the impact of the new *Fair Access to Regulated Professions and Compulsory Trades Act* on PEO and the introduction of mandatory continuous professional development, which begins on January 1, 2023.

# PEO COUNCILLOR RUNS FOR MUNICIPAL OFFICE IN EASTERN ONTARIO

CORNWALL - The list is growing. As reported in the *GLP Weekly Times* issues on September 2 and 16, a number of PEO licence holders are seeking election to municipal office across the province in the October 24 elections.

Most recently, the *GLP Weekly Times* has learned that PEO Councillor **Tim Kirkby**, P.Eng., is also a candidate for the Howe Island ward in the township of Frontenac Islands. In 2018, Mr. Kirkby lost that ward by just three votes.

Mr. Kirkby's volunteerism at PEO spans 25 years in many roles, and he was inducted as a member of PEO's Order of Honour in 2022.

- **John Vieth**, is running as a candidate for Waterloo Region Council. Mr. Vieth is a former PEO Vice President and Councillor.
- Sandra Ausma, P.Eng., is running for Council in the Town of Parry Sound. Ms. Ausma is a former PEO Vice President and Councillor.
- **Guy Boone**, P.Eng., is running in Ward 24 for Ottawa City Council. Mr. Boone is a former Regional Councillor.
- Ian McDougall, P.Eng., is running for re-election as a Councillor in the Township of Scugog.
- Ron Starr, P.Eng., is seeking re-election for the City of Mississauga in Ward 6.
- Angela Vieth, P.Eng., is running for re-election to Waterloo Council.


# GLP IN-PERSON TRAINING TO BE HELD FRIDAY, OCTOBER 21 IN MISSISSAUGA

Representing the chapter and PEO were East Toronto Chapter GLP Chair **Omid Sadeghi**, P.Eng., and **Jaspreet Nijjar**, P.Eng., the new GLP representative for MPP Tabuns' riding. GLP Chapter Coordinator **Julie Hamilton** was also in attendance.

Mr. Tabuns, who was appointed interim leader of the official opposition and New Democratic Party last month, is very familiar with PEO and its mandate. Mr. Nijjar introduced himself as the GLP rep in the new system in which each MPP now has their own GLP rep.

Ms. Hamilton and Mr. Sadeghi were both able to explain to MPP Tabuns PEO's new focus on not only ongoing regulatory issues, particularly in regards to the *Fair Access to Regulated Professions and Compulsory Trades Act* (FARPACTA), but also PEO's focus on bringing in mandatory continuing professional development by January 2023. The mandatory CPD program builds on the voluntary PEAK (Practice Evaluation and Knowledge) program, which was established in 2017.


Mr. Tabuns meets regularly with the East Toronto Chapter, but said it would be difficult over the next six months to attend PEO events until he completes his term as interim leader.
