# OPPORTUNITY FOR LICENCE HOLDERS TO VOTE IN JULY 27 BY-ELECTIONS

As announced in PEO GLP Weekly Times on June 30, by-elections have been called for the ridings of Kanata-Carleton and Scarborough-Guildwood. Candidates are listed below. Additional candidates have now been named, see photos below.

The by-elections follow the resignations of former Ontario Minister for Long-Term Care **Merrilee Fullerton**, and former Liberal Deputy Leader **Mitzie Hunter**.

A third by-election is expected to be called shorty to replace outgoing Kitchener Centre MPP **Laura Mae Lindo**.

By-elections are an important opportunity for PEO licence holders to meet local candidates and inform them of PEO's mandate as the regulator of professional engineering in the province in the public interest.

### MPP WHO SPOKE AT PEO EVENT LAUNCHES CAMPAIGN

Liberal Health Critic **Adil Shamji**, MPP (Don Valley East) has kicked off his campaign for his party leadership. He made the announcement on July 8.

MPP Shamji is a former emergency physician at Michael Garrett hospital in Toronto. He announced that his campaign will be chaired by former Deputy Premier **George Smitherman** and former Ontario Liberal Party presidential candidate **Natalie Hart**.

MPP Shamji spoke at the PEO East Toronto Chapter Licensing Ceremony on November 24, where he acknowledged the "incredible work the (PEO) Government Liaison Program does... I am the Liberal critic for Health, Northern Development, Indigenous Affairs and Colleges and Universities. In all those portfolios, engineers play a vital role. It's critically important and one of the reasons why it is so important to be here tonight."

MPP Shamji is the fifth candidate in the race to lead the former governing party in Ontario alongside Mississauga Mayor **Bonnie Crombie**, Liberal MPP **Ted Hsu** (Kingston and the Islands); and Liberal MPs **Nate Erskine-Smith** (Beaches-East York) and **Yasir Naqvi** (Ottawa Centre).

He also served as the Minister of Agriculture, Food and Rural Affairs from 1999 to 2001 and 2018 to 2021 as well as Associate Minister of Municipal Affairs (Rural) and Chair of the Legislative Committee on Public Accounts.

He has a long standing interest in PEO's regulatory affairs and in the past intervened on PEO's behalf on issues with appropriate ministries.


