AMHERSTBURG - Essex MPP **Anthony Leardi** was briefed on the regulatory mandate of PEO at a 30 minute meeting at his constituency office on August 15.

MPP Leardi met with PEO Windsor-Essex Chapter representatives **Danny Castellan**, P. Eng., and **Asif Khan**, P. Eng., to discuss the work of the Government Liaison Program. They discussed the possibility of MPP Leardi participating in a fall Take Your MPP To Work day and other initiatives. Mr. Khan is Vice-Chair of the PEO Government Liaison Committee and GLP Chair of the Windsor-Essex chatper.

MPP Leardi's fellow Windsor new PC MPP **Andrew Dowie**, P.Eng., (Windsor-Tecumseh) is the only engineer in the legislature.

MPP Leardi was first elected in 2022. He is the nephew of a former Liberal MPP **Remo Mancini** and replaced long-time NDP MPP **Taras Natychak**.

MPP Leardi is Parliamentary Assistant to the Minister of Mines, **George Pirie**, MPP (Timmins).

SASK. ENGINEER RECEIVES SUSPENSION AFTER BRIDGE COLLAPSES HOURS AFTER OPENING

CLAYTON -- The Association of Engineers and Geoscientists of Saskatchewan has suspended a license holder for 18 months because he designed a bridge that collapsed just hours after it opened to the public.

Licensee **Scott Gullacher** was responsible for the Dyck Memorial Bridge in the Regional Municipality of Clayton, Saskatchewan about 300 kilometres east of Saskatoon. The bridge opened and collapsed on September 14, 2018. No one was injured when it fell into the river.

CBC journalist **Will McLernon** reported that following his 18-month suspension, Gullacher will be barred from working on any bridge project in Saskatchewan for a period of five years. Following this period, Gullacher will undergo three years of direct supervision with additional ethics training during that time.

This event serves as reminder of the obligations of engineering regulators and licensees to always put the public interest first.

HON. MICHAEL FORD, MPP (YORK SOUTH--WESTON)

Minister Michael Ford, MPP (York South--Weston) was first elected in the 2022 provincial election as a Progressive Conservative. He currently serves as the Minister of Citizenship and Multiculturalism.

First elected as a Toronto school trustee in 2014, he later won a 2016 Toronto City Council by-election, serving in this role until 2022.

Chris Glover, MPP (Spadina--Fort York) was first elected as a member of the New Democratic Party to the Ontario Legislature in 2018, and re-elected in 2022. He is currently the Official Opposition Critic on Democratic Reform, and Technology, Development, and Innovation.

Prior to his election to the legislature, MPP Glover was a Toronto District School Board Trustee, a member of the Toronto Board of Health and an Adjunct Professor at York University.

MPP Glover is a regular participant in PEO East Toronto Chapter events.
