# LABOUR MINISTRY MAKES CHANGES TO CRANE SAFETY REQUIREMENTS

The Ontario Ministry of Labour, Immigration, Training and Skills Development has announced regulation changes to improve crane safety on construction sites.

According to the announcement, the changes aim to keep workers and the public safe and avoid work stoppages related to tower crane design, erection and inspection requirements for professional engineers in Ontario.

The changes are related to Regulation 213/91 (Construction Projects) and O.Reg. 420/1 under the *Occupational Health and Safety Act*, and will come into effect on January 1, 2024, and others the following year. The complete proposal may be found on *Ontario's Regulatory Registry*.



Labour, Immigration, Training and Skills Development Minister **David Piccini**, MPP (Peterborough— Northumberland) and his office have brought forward new changes to crane safety requirements in the interest of public and worker safety.

A statement by PEO said: "Professional engineers are required to stay up to date and comply with all relevant codes, standards and regulations as provided by the government or any body issuing them.

"PEO will be issuing a practice bulletin to provide more detail for professional engineers doing this work while we update PEO's Review of Tower Cranes as Required by the Occupational Health and Safety Act Practice Standard."

"Engineering plays a crucial role in achieving the goal of minimizing the environmental impact, protecting public health, and maximizing the efficiency of waste management systems," said Mr. Khan.

"This event unmistakably demonstrated that the GLP Program has successfully achieved its objectives, evident from the reactions and interests of the participants. Overall, the event was a resounding success," said Mr. Khan. "We eagerly look forward to future collaborations."

Throughout her tenure, Lieutenant Governor Dowdeswell has met with professional engineers across the province.

Succeeding Lieutenant Governor Dowdeswell will be educator **Edith Dumont**. Ms. Dumont will be the first Francophone Lieutenant Governor in Ontario's history.
