# PEO UPDATES ON ACOUSTICAL ENGINEERING SERVICES IN ENGINEERING DIMENSIONS

As featured in the most recent issue of *Engineering Dimensions*, **Adam Sidsworth** wrote a piece regarding PEO's ongoing commitment to update its practice guidelines.

PEO's updated guideline "Professional Engineers Providing Acoustical Engineering Services in the Land Use Planning Process" offers advisory support for engineers and professionals involved in environmental noise and vibration related to land use approval, design, and implementation. The updated guideline covers qualifications for acoustical engineers, noise and vibration studies, land use compatibility, mitigation strategies, and compliance with provincial and municipal regulations.

PEO, as part of its 2023–2025 Strategic Plan, is committed to updating standards and guidelines older than five years, ensuring alignment with current legislation and definitions. The revised guideline will be available on PEO's website, and updates can be received through their <u>free subscription service</u>.

# PEO CEO/REGISTRAR HIGHLIGHTS KEY INITIATIVES IN *ENGINEERING DIMENSIONS*

PEO's CEO/Registrar **Jennifer Quaglietta**, P.Eng., provided a featured report in the most recent issue of <u>Engineering Dimensions</u> which focused on moving ahead in 2024, refining important initiatives, and continuing PEO's digital transformation.

She also reported the completion of 23 deliverables under the 2023 Operational Plan, emphasizing a focus on data-driven analysis to better serve the public interest in 2024. She also highlighted key initiatives for 2024, including the Event Engagement Model aimed at enhancing dialogue with licence holders and stakeholders.

Regarding Practice Evaluation and Knowledge (PEAK), she noted changes such as exempting retired licence holders from participation, stating, "Council unanimously agreed with this recommendation, recognizing that those on fee remission pose a comparatively low risk to public safety because they agree not to practice professional engineering." PEO is implementing changes to enhance the mandatory continuing professional development program based on feedback received throughout 2023.

She emphasized PEO's commitment to digital transformation, aiming to enhance cybersecurity, streamline processes, and ensure data reliability. "PEO's journey of digital transformation leverages technology as a key enabler and aims to enhance licence holder and staff experience, protect licence holder and staff data, streamline processes, and ensure ease of use," she said. With these changes, PEO strives to continue serving the public effectively and ensuring optimal service as a regulator.
