# SMALL BUSINESS MINISTER DISCUSSES LICENSING WITH PEO MISSISSAUGA CHAPTER

MISSISSAUGA - **Nina Tangri**, MPP (Mississauga - Streetsville), Associate Minister of Small Business met with PEO GLP Mississauga Chapter representatives on February 7 at the Minister's constituency office. Representing the chapter were GLP Chair **Jeannette Chau**, P.Eng., and GLP Rep **Ariej Ibrahim**, P.Eng., who represents Minister Tangri's riding.

The discussion centred on PEO's role in licensing the profession across the province, distinguishing PEO's positions and role with other engineering organizations in Ontario, as well as the *Fair Access to Regulated Professions and Compulsory Trades Act* (FARPACTA) and mandatory continuing professional development/PEAK.

Minister Tangri was first elected in 2018.

She recognized PEO for their contributions to licensing new engineers, and building and improving infrastructure to 'Grow Ontario.' She also congratulated "PEO's leadership in becoming the first regulatory body to remove the Canadian experience requirement to obtain a professional licence." She acknowledged that with "nearly 60 per cent of PEO's licence applications being from internationally trained engineers, taking that barrier down was the right thing to do."

She said that PEO's move to remove the barrier for internationally trained engineers was "a game-changer for newcomers and for businesses struggling with labour shortage."

She has previously participated in PEO events, and has provided remarks for previous Kingsway Chapter AGMs.

### ONTARIO LEGISLATURE TO RECONVENE NEXT WEEK









The Ontario Legislature is poised to resume its sessions next Tuesday, February 20, following a hiatus since December. As the province gears up for newly proposed legislation, all parties have been actively engaged in various initiatives to bolster their agendas and engage with constituents.

All four party leaders have been busy preparing for the new legislative session. Premier **Doug Ford**, MPP (Etobicoke North) participated in a meeting with the Mississauga Board of Trade on February 8, where PEO Government Relations Consultant **Howard Brown** had the chance to speak with him. Opposition Leader **Marit Stiles**, MPP (Davenport), Liberal Leader **Bonnie Crombie**, and Green Party Leader **Mike Schreiner**, MPP (Guelph) have all been active as well.
