



They discussed the Fair Access to Regulated Professions and Compulsory Trades Act and Mandatory Continuing Professional Development / PEAK. They also discussed MPP Coe's participation in the PEO licensing ceremony that will be held in Whitby on February 9. MPP Coe was first elected in 2016.

The Women in Engineering Conference, held at Toronto Metropolitan University on February 3, marked a significant event for diversity and advancement within the engineering profession. PEO Lake Ontario Chapter Rep **Wintta Ghebreiyesus**, P.Eng., and **Tracey Caruana**, P.Eng., Manager, EIT and Student Programs, were participants.

Ms. Ghebreiyesus said her engagement highlighted the GLP's role in fostering dialogue between engineers and government to ensure the profession's voice is heard.

One of the sessions, "Clarifying the Path to P.Eng.," was led by Ms. Caruana. Ms. Ghebreiyesus said that the session addressed the unique challenges and opportunities for women becoming licensed in engineering.

Recent enhancements to the PEO licence application process have underscored PEO's commitment to making the journey towards a professional engineering designation both efficient and transparent.

Also participating in the conference was Attorney General **Doug Downey**, MPP (Barrie - Springwater - Oro-Medonte) who is responsible for the *Professional Engineers Act*.

The conference was co-chaired by **Sam Oosterhoff**, MPP (Niagara West), Parliamentary Assistant to the Minister of Red Tape Reduction, and **Patrice Barnes**, MPP (Ajax), Parliamentary Assistant to the Minister of Education.

Currently, there is one Professional Engineer sitting in the Ontario Legislature, **Andrew Dowie**, P.Eng., MPP (Windsor-Tecumseh) who previously served as the GLP Chair for the Windsor-Essex Chapter, and as the Vice-Chair of PEO Government Liaison Committee.
