The AGM was attended by over 150 in-person attendees, as well as nearly 400 virtual guests.

Minister Downey thanked PEO leadership, particularly CEO/Registrar Jennifer Quaglietta, P.Eng., and 2023-24 President Roydon Fraser for their work over the past year, and expressed that he was looking forward to working with new PEO President Gregory P. Wowchuk, P.Eng. He also acknowledged that this was the first time he was able to attend an AGM in person, as he previously participated online, and took the opportunity to invite PEO to participate in the upcoming legislative review of the Construction Act. Minister Downey also recognized former Attorney General Roy McMurtry, who he said was also a strong supporter of PEO and its role as the regulator of professional engineering in the province. Minister McMurty passed away on March 18.

Past President Fraser spoke about his appreciation for the work of Council over the previous year. His address looked to the future of professional engineering, and the role of PEO as the provincial regulator. A portion of how President Fraser looked to guide future discussions was through a seminar later in the day, which looked to craft a vision statement that would guide PEO to 2050.

Ms. Quaglietta also delivered her report to the AGM, which included highlighting over 4,000 licences being issued, as well as the current rates of PEO members completing continuing professional development/PEAK.

FORMER PEO COUNCILLOR-AT-LARGE SWORN IN AS THE NEW PEO PRESIDENT

PEO West Central Chapter's **Gregory P. Wowchuk**, P.Eng., was sworn in as the new President of PEO at the 102nd AGM on April 20.

As noted on PEO's website, President Wowchuk holds a BASc degree from the University of Windsor and a diploma in electrical technology from the former Ryerson Polytechnical Institute (now Toronto Metropolitan University), reflecting his affinity for both the theoretical and the practical. Along with his engineering education, he has also taken courses in psychology and effective communication.

He began his career in the defence systems division of Spar Aerospace Limited. He is currently president of Wheatfield Instrument Corporation Ltd. and a special advisor to Dynamic Solutions Institute of Applied Knowledge Inc. in Detroit, MI. He has served as PEO councillor-at-large (2018–2020), a Lieutenant Governor-in-Council appointed councillor (1997–2000) and chair of the former Communications Committee (1997–1999).

He also holds a black belt in traditional Japanese karate, is an aficionado of old cars and enjoys pulling, modifying and rebuilding their engines. He views the role of PEO Council as serving the profession and protecting the public interest. He firmly believes these two functions are not mutually exclusive.



EARTH DAY: HIGHLIGHTING PEO'S SUSTAINABILITY EFFORTS



PEO celebrated Earth Day on April 22. As reported on PEO's LinkedIn page, they profiled PEO's commitment to sustainability. A post said "under the *Professional Engineers Act*, Ontario's professional engineers commit to safeguarding the environment. They're prepared to apply the most current technology in an environmentally sustainable and cost-effective way to benefit society's evolving needs."

PEO follows the 10 sustainable development and environmental stewardship guidelines set by Engineers Canada, which state that engineers should:

- Maintain and continuously improve awareness and understanding of environmental stewardship, sustainability principles and issues related to their field of practice;
- Use expertise of others to adequately address environmental and sustainability issues and enhance understanding and improve practices;
- Incorporate global, regional and local societal values applicable to their work;
- Establish mutually agreed sustainability indicators and criteria for environmental stewardship at the earliest possible stage in projects, and evaluate these periodically against performance targets;
- Assess the costs and benefits of environmental protection, eco-system components, and sustainability in evaluating the economic viability of the work.
