OPENING REMARKS BY CHAPTER CHAIR

2024 FINANCIAL REPORT




The chapter's annual financial report was prepared by the Treasurer, Mark Simpson, P. Eng for the fiscal year 2024. The approved budget was \$12,660, while net expenses amounted to \$6,368, leaving a 49.7% of the approved budget as surplus The surplus resulted from zero claims for child support by the executive and the chapter's inability to hold a spring event the previous year. The child support is intended to encourage and incentivize new and young members to get involved in chapter activities without incurring such costs at an individual's expense.

Mark stated that the 2026 budget is in the works, which shall be presented at the next Executive meeting and forwarded to PEO council

during the third quarter of the fiscal year.

REMARKS BY THE CHAIR, GOVERNMENT LIAISON PROGRAM, GLP



Our Government Liaison Program (GLP) Chair, Larry Drebert, P.Eng, reported on his collaboration and communication with the provincial government regarding the recognition of the PEO as a self-regulating professional body. The GLP holds an annual conference to train volunteers for provincial chapter responsibilities, recognizes milestones, and tracks volunteers' lifecycles. He stated that we are in for another exciting year and went on to introduce our new volunteer member, Aidan Vandersteen, P.Eng, who will work with Larry for future opportunities.

A.G.M LECTURE ON REGULATORY COMPLIANCE by Guest Speaker: Ashley Gismondi, MPA



Ashley Gismondi, MPA, Enforcement and Outreach Officer, Regulatory Compliance at the PEO HQ, walked us through the Ontario Regulation 941 which addresses professional misconduct, the code of ethics, and reporting requirements, and Ontario Regulation 260 which addresses professional standards and design standards.

Ashley delved into negligence in professional practice, violations of the Professional Engineers Act (PEA), incompetence, harassment, etc. Ashley gave us an overview of the various license types, PEO practice guidelines, regulated professions, unlicensed practice enforcement, operational

highlights on professional seal use, Ontario provincial court rulings on breach of professionalism for PEA offences, major successes recorded, and costs awarded to the PEO for infringements.
